BONU Privacy Policy

Your privacy on the Internet is of utmost importance to the Botswana Nurses Union (BONU). This privacy statement describes BONU's policy concerning the gathering and sharing of visitors' information through the BONU web site. It applies to all "BONU sites" – that is, www.bonubw.org as well as other BONU microsites.

What information does BONU collect? Normal web site usage

In general, you can browse the BONU site without telling us who you are or revealing any personal information about yourself. The only information we gather during general browsing is from standard server logs. These include your IP (Internet Protocol) address, domain name, browser type, operating system, and information such as the web site that referred you to us, the files you download, the pages you visit, and the dates/times of those visits.

Collection of personally identifiable information

If you register for a news updates, log on to certain BONU sites, order a publication, request information, provide feedback, apply for membership, join a discussion group or join an electronic mailing list, you will be asked to provide personal information such as your name, postal address and e-mail address.

This information is collected only with your knowledge and permission, and is kept in various BONU databases and mailing lists. If you are purchasing something using the web, you may be asked to provide your credit card details. These details are transferred to a secure, online payment service, hosted outside BONU. Credit card information is not retained by BONU.

BONU sites with specific requirements to collect personal information may publish a privacy policy specific for that site. In these cases, the site-specific policies will be complementary to this general BONU privacy policy, but will give additional details for that particular site.

For certain BONU sites, registering or supplying personal information sets a cookie*. By setting this cookie, BONU will remember your details the next time you visit, so you don't have to re-enter the information. This helps us to provide you with a better service.

Joining electronic discussion groups may mean that other participants of the discussion group (including non-BONU employees) will see personal information that you have volunteered. For open discussion groups, this information will be public.

What does BONU do with the information it collects? Normal web site usage

The information gathered during general browsing of the "bonubw.org" domain is used to analyse trends and usage of the BONU site and to improve the usefulness of the site. It is not connected with any personal information.

Personally identifiable information

BONU may use the personal information you provide to:

- Contact you – either in response to a query or suggestion, or to mail newsletters, documents, publications etc. to you;
- Manage and process your membership application;
- Confirm your purchases and registrations on the site;
- Obtain payment for purchases through the site (via credit card);
- "Remember" your online profile and preferences;
- Help you quickly find information that is relevant to you based on your interests, and help us create site content most relevant to you;
- Statistical analysis.

What if I don't want to provide personal information?

Providing personal information on the BONU site is optional. If you choose not to provide personal information, you can still browse and use the BONU site, but you will not be able to carry out certain actions such as purchase items, register for a newsletter or apply for membership.

Opting out and changing your information

At any time, you can cancel or modify your information by returning to the web page where you first provided the information and contacting the focal point for that page/BONU department. Where contact details are not provided on the page, you can contact us at **info@nab.org.bw** for further information.

Security

We do not sell or share any personally identifiable information volunteered on the BONU site to any third party. Any information provided to BONU by users of the BONU site is held with the utmost care and security, and will not be used in ways other than as set forth in this privacy policy, or in any site-specific policies, or in ways to which you have explicitly consented. BONU employs a range of technologies and security measures to protect the information maintained on our systems from loss, misuse, unauthorized access or disclosure, alteration, or destruction.

All our employees who have access to, and are associated with the processing of personal data, are obliged to respect the confidentiality of official business matters, including personal data.

The BONU site contains links to sites external to the bonubw.org domain. BONU is not responsible for the privacy practices or the content of such sites.

***Cookies**

A cookie is a small amount of data that is sent from a web server to your browser. It is normally used to assign a unique identification to your computer and securely store information such as user IDs, passwords, preferences, and online profiles.

It is stored on the hard drive of your computer. You can choose not to have cookies delivered by BONU sites by changing your browser settings. Different web sites can send their own cookies to your computer. To protect your privacy, your browser only allows a web site to access the cookies it has already sent you, not the cookies sent by other sites.
